

MICROSOFT TEAMS COLLABORATORIUM SWEEPSTAKES OFFICIAL RULES

1. SPONSOR

These Official Rules ("Rules") govern the operation of the Microsoft Teams Collaboratorium Sweepstakes ("Sweepstakes"). Microsoft Corporation, One Microsoft Way, Redmond, WA, 98052, USA, is the Sweepstakes sponsor ("Sponsor").

2. DEFINITIONS

In these Rules, "Microsoft", "we", "our", and "us", refer to Sponsor and "you" and "yourself" refers to a Sweepstakes participant, or the parent/legal guardian of any Sweepstakes entrant who has not reached the age of majority to contractually obligate themselves in their legal place of residence. "Event" refers to the Microsoft Teams Collaboratorium event held in Teams Live Events. By entering you (your parent/legal guardian if you are not the age of majority in your legal place of residence) agree to be bound by these Rules.

4. ELIGIBILITY

Open to any registered Event attendee 18 years of age or older who is a legal resident of the 50 United States (including the District of Columbia). If you are 18 years of age or older but have not reached the age of majority in your legal place of residence, then you must have consent of a parent/legal guardian.

You will receive one Sweepstakes entry when you register and login to the Session. Limit one entry per person per Session, and a limit of four entries per Series.

Any attempt to obtain more than the stated number of entries by using multiple/different accounts, identities, registrations, logins, or any other methods will void your entries and you may be disqualified. Use of any automated system to participate is prohibited.

We are not responsible for excess, lost, late, or incomplete entries. If disputed, entries will be deemed submitted by the "authorized account holder" of the email address, social media account, or other method used to enter. Within 90 days following each Series, one potential First Prize winner will be selected by Microsoft or their Agent for each Session, in a random drawing from among all eligible entries received during that applicable Session.

Within 90 days following each Series, one Grand Prize winner will be selected for each Series by Microsoft or their Agent in a random drawing from among all eligible entries received during that applicable Series.

Non-winning entries from Series 1 will not carry over into Series 2. You must enter each Series separately.

Winners will be notified via the contact information provided during entry no more than 7 days following the drawing with prize claim instructions, including submission deadlines. If a selected winner cannot be contacted, is ineligible, fails to claim a prize or fails to return any forms, the selected winner will forfeit their prize and an alternate winner will be selected time allowing. Only three alternate winners will be selected, after which unclaimed prizes will remain unawarded. If you are a potential winner and you are 18 or older, but have not reached the age of majority in your legal place of residence, we may require your parent/legal guardian to sign all required forms on your behalf.

Rules and the date the prize is awarded or redeemed. We will determine the value of the prize to be the fair market value at the time of prize award.
