Developer Code of Conduct for Microsoft Cognitive Services

We would like to ask for your help in protecting the people whose data your app, service or project sends to Microsoft Cognitive Services. This Code of Conduct outlines basic steps we would like you to take, and is not a substitute for legal advice. You are responsible for complying with laws that apply to you, including privacy laws.

Do's

- Consent:
 - o We require that you obtain sufficient consent from the people whose data (such as images, voices, video or text) is sent to Microsoft's Cognitive Services. We ask that you include a prominent notice in your UI so your users know that consent is required.

- Reporting abuse & requests to access or delete personal information:
 - o We ask that you have a way for your users to report abuse to you, and for you to handle access and deletion requests (e.g. someone deletes their account and would like to have all of their data deleted as well).
- Attribution:
 - We require that you include reasonably prominent attribution to Microsoft Cognitive Services in your app, service or project. The attribution should read "using Microsoft Cognitive Services" and include a hyperlink to http://go.microsoft.com/fwlink/?LinkID=829046.
- Review your Microsoft Account security:
